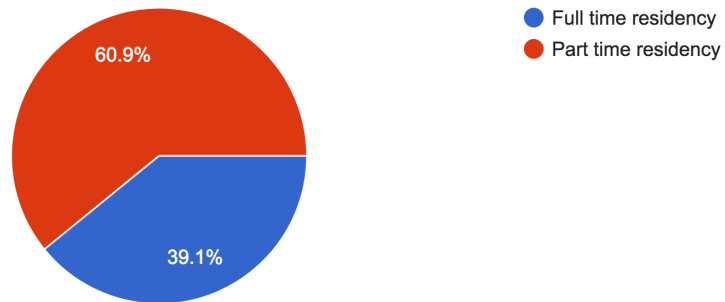

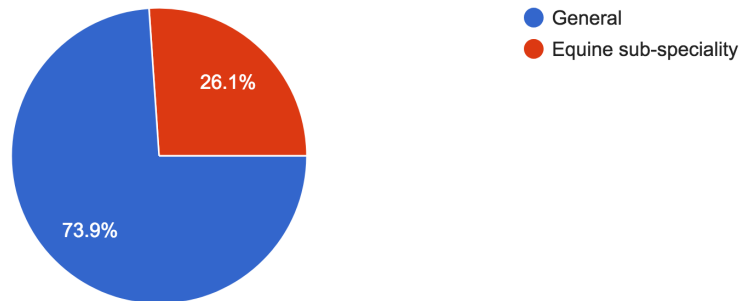
1. What type of residency are you currently enrolled in?

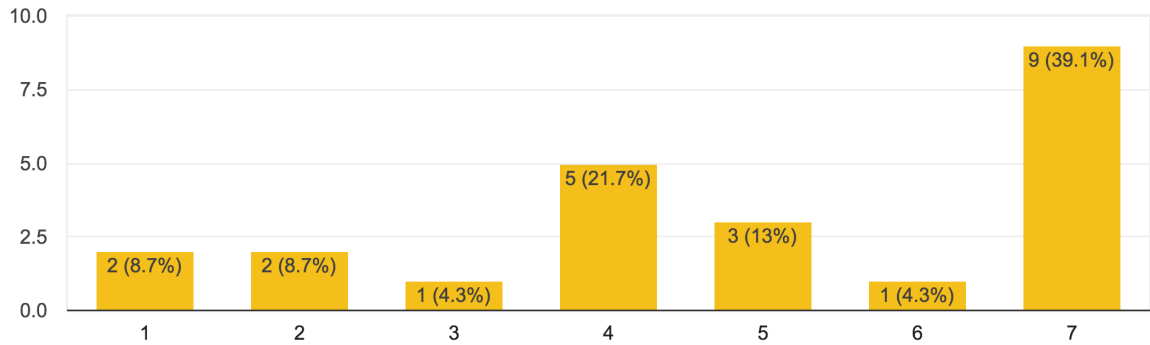
2. What is the species focus of your residency?

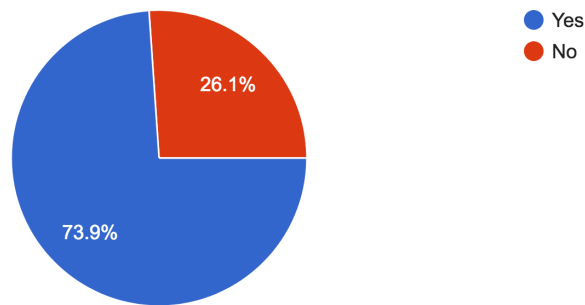

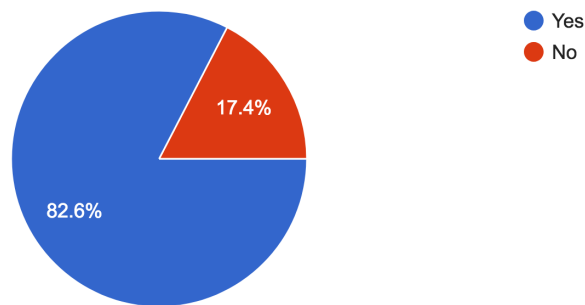
4. Do you feel the pandemic has significantly affected your ability to fulfill all the EVDC residency requirements?

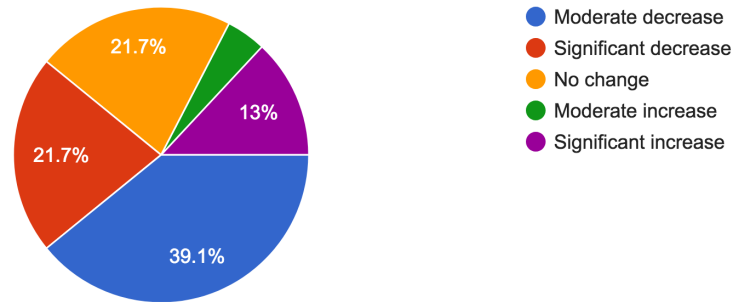
5. Has your ability to work with your supervisors been affected as a result of the pandemic?

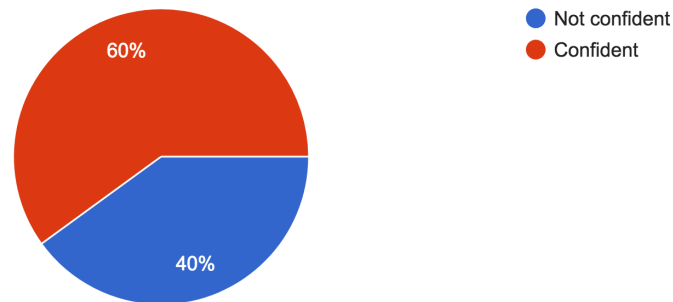
6. How has your caseload changed since the start of the pandemic?

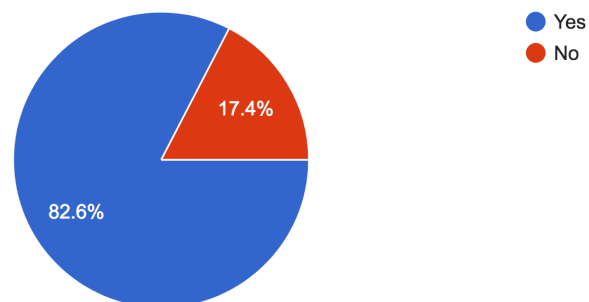
7. If a decrease in caseload has occurred, are you confident that you will be able to meet the MRCL requirements by the end of your residency?

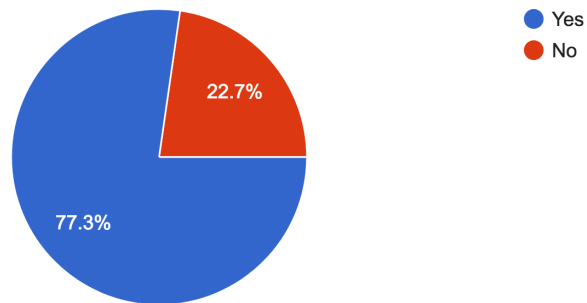
8. Has the pandemic limited your ability to complete the specialist hours requirement?

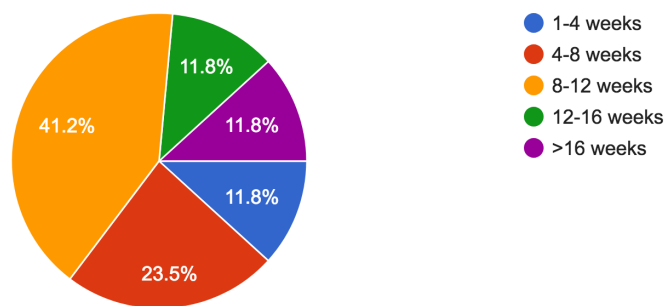
9. Has the pandemic limited the amount of diplomate direct supervised time you have been able to complete?

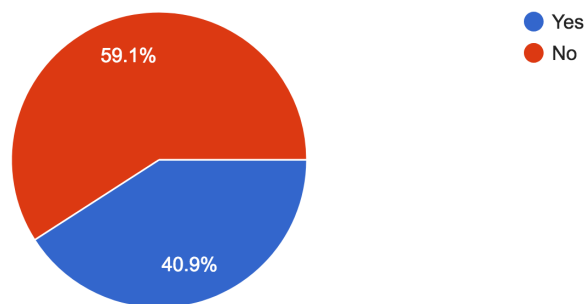
10. If you answered Yes to Question 9 above, how much supervised time do you consider you have lost?

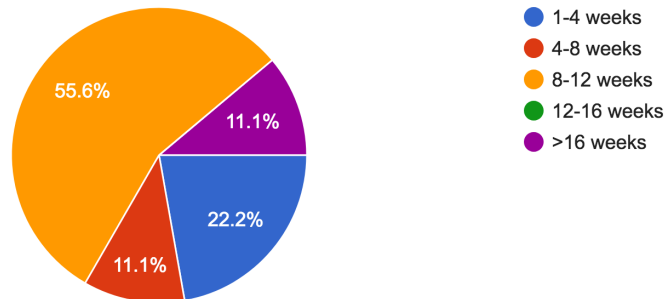
11. Has the pandemic limited the amount of un-supervised time have you been able to complete?

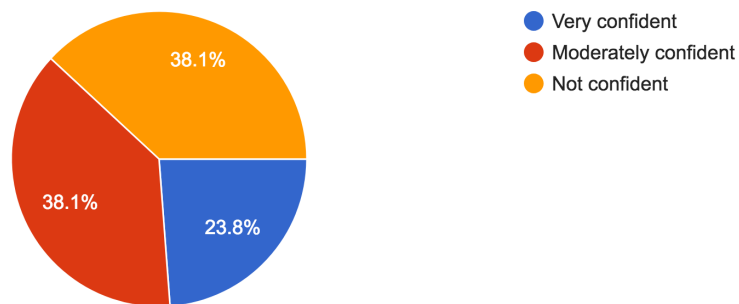
12. If you answered Yes to Question 11 above, how much un-supervised time do you consider you have lost?

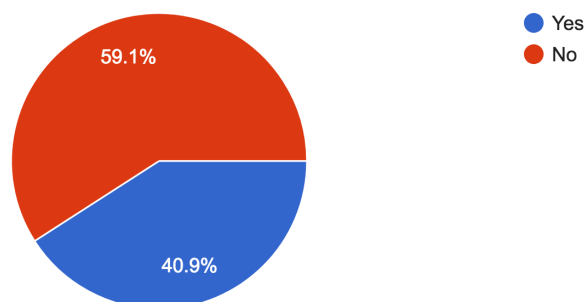
13. Considering how far along you are with your residency i.e. time to credentialing, how confident are you that you will be able to make up any lost supervised time before the end of your residency?

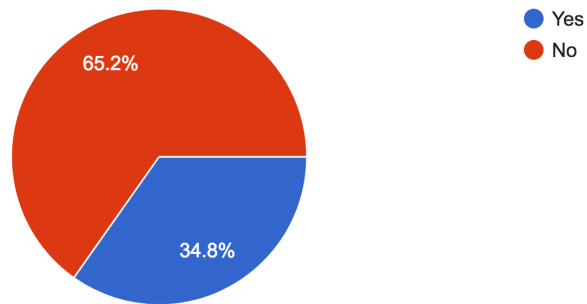


14. Has the pandemic limited your ability to perform any planned research for the publication requirement?

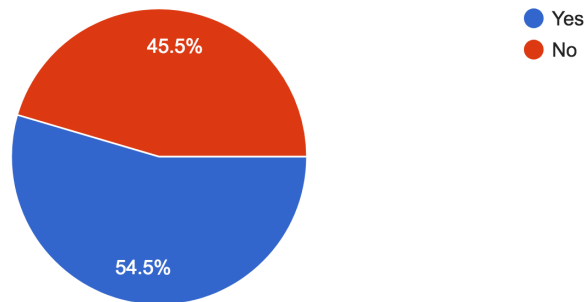

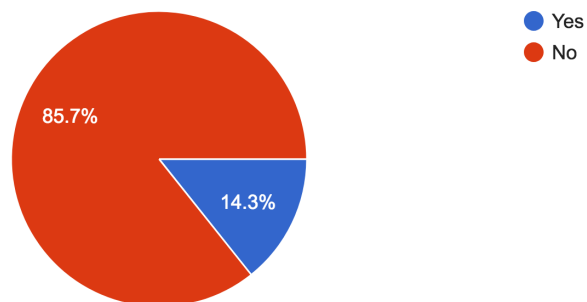
15. Are you aware of the establishment in 2020 of the EVDC Resident COVID support group?

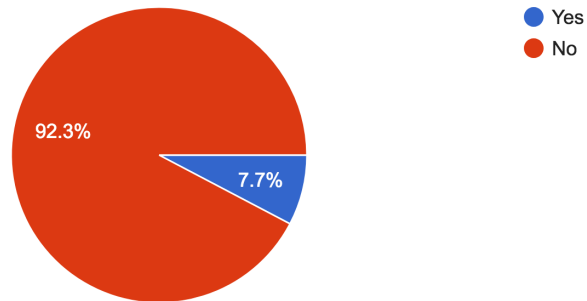


17. If you answered Yes to the Question 16 above, have you made use of the cadaver allowances to date?

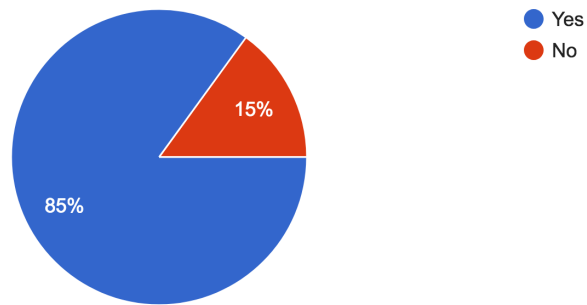
18. If you answered Yes to Question 16 above, have you made use of the remote supervision to date?

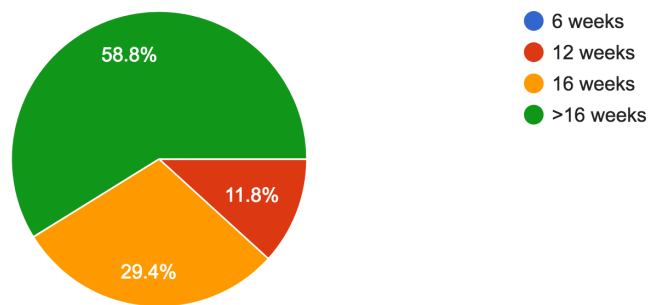

Expand supervised hours to greater proportion of residents than only for those in the last 18 months.

To prolong the possibility of online supervised time in 2021, so far I understood it was valid only in 2020

The pandemic may limit travel to other clinics which would assist me in completing MRCL cases such as PR, OR4 and PE4. Allowing 25% cadaver cases in each category does not assist me in this area, but allowing a greater total number of cadaver cases would assist me. And especially in the OR4 category, I may not complete a clinical case by the end of the year, when I intend to submit my credentials package.
